Step 4: Conduct a USPTO Trademark Search (https://tmsearch.uspto.gov/bin/gate.exe?f=searchss&state=4809:702x4u.1.1)



If no exact and/or similar matches show, then move forward with registering your name

Step 1: Determine Type of Business You Will Form

Sole Proprietorship

General Partnership

Limited Partnership

C Corporation

S Corporation

LLC





Step 2: Identify Your Registered Agent

Registered Agents Perform the Following Functions:

- Receive and forward legal notices
- Have a physical presence in jurisdiction
- Support local compliance activities, i.e. file annual reports
 - Receive and respond to other communications

Step 4: Secure Licenses and Permits

 - Stock Certificates (if applicable)
 - Corporate Seal
